Greetings,

We hope you enjoy this issue of the National Council Monthly Update summarizing the pertinent operations at VFW National Headquarters over the last month.

Development

March marked a strong performance for Development. Revenue was projected at \$5.2 million, and we closed the month exceeding expectations by \$829,000.

While we are experiencing a successful fundraising year, we remain vigilant in monitoring external economic factors such as tariffs, inflation, and recession concerns which can strongly influence donor generosity. At the same time, we believe that recent changes being proposed within the VA have ignited a renewed sense of urgency and passion among donors who are deeply committed to supporting veterans' causes. This momentum reinforces the importance of our mission and continues to drive strong philanthropic engagement.

We are also closely monitoring Planned Giving revenue. Although we remain ahead of last fiscal year's numbers, the pace of planned gifts has slowed, and we've fallen below projections for several consecutive months. Given the unpredictable nature of these types of gifts, forecasting remains a challenge, and we continue to track trends and adjust expectations accordingly.

National Veterans Service

The deadline for submitting nominations for the John A. Biedrzycki Accredited Service Representative of the Year Award for 2024-2025 is April 30, 2025. Each Department Commander may nominate one eligible individual for this award. The individual who is ultimately chosen as the recipient of the award will be furnished round trip travel (for the winner and one guest) and two nights hotel accommodations to attend the VFW National Convention where the award will be presented. In addition, the award recipient will receive \$599 in recognition of their accomplishments and to offset travel expenses. We encourage every Department to put forth a candidate.
