## **Development**

In April, Development surpassed its revenue goal of \$4,952,531, closing the month at \$4,987,579 — exceeding projections by \$35,000. While this marks a positive outcome financially, we began to observe a softening in donor engagement, particularly within our monthly giving program. A noticeable uptick in cancellation requests was noted, with many donors citing economic uncertainty and concerns about a potential recession's impact on their fixed income as their primary reason for discontinuing support.

In response, we have proactively offered flexible giving options and reassurances to help donors feel more comfortable maintaining their contributions to the VFW. We continue to monitor giving trends closely and remain agile in our strategies to ensure ongoing progress toward our annual revenue objectives.

## **Legal Counsel**

The VFW filed an *amicus curiae* ("friend of the court") brief urging the U.S. Supreme Court to grant review in *Hencely v. Fluor Corporation*, a case concerning the rights of injured service members and the legal accountability of defense contractors operating in combat zones.

The case involves Specialist Winston Tyler Hencely, a former soldier in the U.S. Army who was seriously wounded in a suicide bombing at Bagram Airfield, Afghanistan, in 2016. The incident occurred when a local worker employed by a subcontractor of Fluor Corporation — a major defense contractor — detonated a suicide vest concealed beneath his clothing, killing himself and five others, and severely injuring seventeen

more, including Specialist Hencely. The Taliban claimed responsibility, stating the attack had been planned for months.

Hencely sued Fluor for negligence, asserting the company failed to screen or supervise its contracted Afghan laborers despite known risks of insider attacks. Lower courts dismissed the case on reasons derived from the Federal Tort Claims Act (FTCA) and the political questions involved.

Although the FTCA governs claims against the United States — not private contractors — the court applied its underlying principles to Fluor. It concluded that adjudicating Hencely's claims would require the judiciary to second-guess military decisions and operational risk assessments, and thus the case was nonjusticiable. In effect, the court extended the immunity protections typically afforded to the government under the FTCA to a private contractor, even though the alleged negligence concerned employment practices rather than combat activities.

The VFW's brief strongly objects to this logic, arguing that extending FTCA immunity to private contractors erodes accountability, denies justice to injured veterans, and leaves critical gaps in oversight. The brief urges the Supreme Court to clarify that contractor negligence — particularly in matters unrelated to battlefield decision-making — must remain subject to judicial review.

By supporting the petition, the VFW seeks to ensure that veterans' rights are respected and that private contractors operating in war zones are held to legal and ethical standards. If granted, the case would be argued next term.

- This is a reminder to please send your Department approved resolutions and/or amendments to the National Bylaws, Manual of Procedure and Ritual that require action by the National Convention, immediately following the close of your Department Convention.

In order to meet the requirements mentioned in Article XIV of the National Bylaws/Manual of Procedure, stating “All proposed amendments will be available to Posts by the Adjutant General at least fifteen (15) days before the assembling of the National Convention for those amendments being proposed for consideration at the convention”.

**It is extremely important we receive these documents within two (2) days from the conclusion of your Department Convention. A response is required even if your Department does not have any resolutions/amendments to submit.**

### **Election Reports**

- 2025-2026 Election Reports have been mailed out. To access the election report online; sign in to VFW.org and proceed to My VFW. Select Online Membership System (OMS), then press the drop-down menu on the left side of the screen for Election Report and select Post Election Report Filing. **NOTE: The National Bylaws and Manual of Procedure require a properly completed Election Report for the ensuing year to be submitted to the Department and National Headquarters by June 1.**

### **Department Officer Proof of Eligibility**

- With the start of Department Conventions right around the corner I want to remind everyone of the requirement to submit proof of eligibility for all newly elected Junior Vice Commanders and any elected Department Quartermaster or appointed Department Adjutant who are new to their position this coming year (2025-26).

Additionally, proof of eligibility is required for any new Department Commander or Senior Vice Commander, who for whatever reason were not in the line of succession the previous year, to which we already have proof of eligibility on file.

This proof of eligibility must be submitted to the Adjutant General pursuant to Section 516 of the National Bylaws and Manual of Procedure.
