Development

May proved to be another successful month for VFW fundraising efforts. Our revenue goal was \$4.8 million, and we closed the month exceeding expectations with over \$6 million raised. While Planned Giving revenue continues to trend below monthly projections, it's important to recognize that this area inherently involves longer timelines and unpredictable realization of bequests. That said, I remain confident that the cultivation strategy and targeted outreach currently in place are effectively laying the groundwork for future success.

As you travel to your Department conventions, please take the opportunity to educate your fellow members on the significant impact this revenue has on sustaining and expanding VFW programs. Your voice helps demonstrate the importance of continued support and engagement across all levels of the organization.

Department Approved Resolutions and Amendments

• This is a reminder to please send your Department-approved resolutions and/or amendments to the National Bylaws, Manual of Procedure and Ritual that require action by the National Convention, immediately following the close of your Department Convention.

In order to meet the requirements mentioned in Article XIV of the National Bylaws/Manual of Procedure, stating "All proposed amendments will be available to Posts by the Adjutant General at least fifteen (15) days before the assembling of the National Convention for those amendments being proposed for consideration at the convention".

It is extremely important we receive these documents within two (2) days from the conclusion of your Department Convention. A response is required even if your Department does not have any resolutions/amendments to submit.

Election Reports

The June 1 deadline to submit election reports for the ensuing 2025-26 term has passed. Failure to meet this requirement will result in Post suspensions by the Commander-in-Chief which will be issued in the coming weeks.

To date there are 321 Posts organizationally wide who have failed to meet this requirement. Departments should be working with these Posts to clear this deficiency as soon as possible.

Department Officer Proof of Eligibility

• With the start of Department Conventions, I want to remind everyone of the requirement to submit proof of eligibility for all newly elected Junior Vice Commanders and any elected Department Quartermaster or appointed Department Adjutant who are new to their position this coming year (2025-26).

Additionally, proof of eligibility is required for any new Department Commander or Senior Vice Commander, who for whatever reason were not in the line of succession the previous year, to which we already have proof of eligibility on file.

This proof of eligibility must be submitted to the Adjutant General pursuant to Section 516 of the National Bylaws and Manual of Procedure.

This must be done <u>after</u> officers are installed and <u>prior</u> to National Convention and is most easily completed by sending documentation via email to Joseph Wolfgeher at <u>JWolfgeher@vfw.org</u>.

National Legislative Service

- VFW Meets with House Subcommittee Chairwoman: VFW National Senior Vice Commander Carol Whitmore and National Legislative Service Director Kristina Keenan met with House Committee on Veterans' Affairs Subcommittee on Health Chairwoman Mariannette Miller-Meeks. They discussed the <u>VFW's legislative priorities</u> including needed research on alternative treatments for post-traumatic stress disorder, and ways to improve VA's Foreign Medical Program.
- VFW Meets with Committee Leadership: VFW Washington Office Executive Director Ryan Gallucci and National Legislative Service Director Kristina Keenan had meetings with Senate Committee on Veterans' Affairs Ranking Member Richard Blumenthal and House Committee on Veterans' Affairs Ranking Member Mark Takano to discuss the <u>VFW's legislative priorities</u> and our call to <u>Honor the Contract</u> to ensure that veterans receive the benefits they have earned and deserve as promised in military service contracts.

- Take Action to Say NO to Putting Veterans in Debt: Make your voices heard by taking action TODAY. Veterans should never go into debt to access their earned benefits! The VFW has repeatedly expressed concerns about charging veterans for initial claims assistance based on their future benefits, and thus, we strongly oppose H.R. 3132, CHOICE for Veterans Act of 2025, as written. This would potentially put veterans into debt even before utilizing their benefits. <u>Tell your representatives</u> to vote NO when this bill is brought to the House floor for a vote.
- VFW Speaks at Star Act Press Conference: The VFW stood alongside partner Veterans Service Organizations, supporters, and advocates to urge for swift passage of VFW-championed H.R.2102.S.1032, Major Richard Star Act. America's veterans have served and sacrificed for this country, and the VFW is calling upon Congress to pass this commonsense bill to finally take care of medically retired veterans who were wounded in service. Former VFW National Legislative Service Director Pat Murray spoke at the press conference. Watch the press conference.
- House Passes Nine Veteran Bills: The House passed nine bipartisan bills for veterans and their families. The VFW recently provided written testimony in support of H.R. 1286, Simplifying Forms for Veterans Claims Act, that would improve VA forms sent to veterans regarding their claims for benefits; H.R. 1578, Veterans Claims Education Act of 2025, that would inform and provide resources to veterans who file VA disability claims on how to seek free, accredited representation, and how to report unaccredited representatives who charge unauthorized fees for their services; and H.R. 2201, Improving VA Training for Military Sexual Trauma Claims Act, that would provide annual sensitivity training to VA employees who process disability claims for conditions related to military sexual trauma. <u>Read more</u>.
- VFW Joins Roundtable on Underserved Veterans: House Committee on Veterans' Affairs Ranking Member Mark Takano convened a roundtable with veteran organizations and advocacy groups to discuss disparities in access to VA care and benefits for minority and underserved veterans. VFW National Legislative Service Director Kristina Keenan highlighted the need for VA to collect more data to identify areas of need, conduct research on women veterans during all phases of life to include during menopause, reach veterans on tribal lands, and provide mandatory military cultural competency training for Community Care Network providers.

This has been another busy month for NVS and our accredited representatives. Thanks to the efforts of our accredited representatives, veterans and their families represented by the VFW have received more than \$9.2 billion in benefits this fiscal year, which is over an 11% increase from this time last year. - NVS leadership participated in Memorial Day ceremonies in Washington, D.C., to include laying a wreath at the Vietnam Memorial and honoring past VFW Commanders-in-Chief who are buried in Arlington National Cemetery.
- NVS director attended the Grand Ole Opry's Salute the Troops event in Nashville, Tennessee. Presenting sponsor Humana also partnered with

- NVS D.C. staff teamed up with Grunt Style and Irreverent Warriors for a march on Capitol Hill and press conference for awareness of overprescribing psychiatric drugs for veterans.
- NVS leadership participated in the NLS VSO Transition Working Group.
- NVS director will attend the Department of Rhode Island convention as an NVS representative.
- NVS leadership attended the D.C. Mayor's Office Veterans Resource Event in Washington, D.C.
- NVS director participated in Episode 43 of the VFW Still Serving podcast which included Reporting for Duty ... Remotely," a poignant Memorial Day recap, a deep dive into the fight for the Major Richard Star Act, and what veterans really need to know about Claim Sharks and VA transitions.
