General Counsel

Music Licensing for Posts:

We continue to be contacted by Posts in different Departments with concerns about being contacted by companies regarding the need to obtain a license to play music. Please share the following with your Departments and Posts.

The issue is these Posts are playing music without the required license from a Performing Rights Organization (PROs), which collect and distribute royalties to songwriters, composers, and music publishers when their music is publicly performed/played. Generally, under U.S. copyright law, any business or organization that publicly performs copyrighted music must obtain a performance license from the copyright holders or their representatives. This includes playing music over a sound system, jukebox, karaoke machine, live band, or DJ — even if the music is purchased legally.

ASCAP (American Society of Composers, Authors and Publishers), BMI (Broadcast Music International) and SESAC (Society of European Stage Authors and Composers) are the three largest PROs that are charged with collecting royalties for songwriters and publishers for "public performances" of songs in their respective catalogs. Whether your taste in music ranges from Billie Eilish to Englebert Humperdinck, Posts should be licensed to play it.

If the Post is running a business, then it is considered a business with all strings attached. For music, the Posts do not own the rights to play the songs for commercial use. That is a matter of licensing.

If you neglect the requirements that pertain to playing music in your Post and just turn a device on and play what you want, you open your Post to legal claims by music rights holders, which could be very costly.

There is, however, a **limited statutory exemption** that may apply to certain events held by nonprofit veterans' organizations and fraternal organizations. This exemption is found in 17 U.S.C. § 110(10) of the U.S. Copyright Code.

To qualify for this exemption:

1. The organization must be a nonprofit veterans or fraternal organization of the Internal Revenue Code (which includes VFW Posts).

- 2. The music must be nondramatic, such as typical songs played on the radio or at social events (not musicals or operas).
- 3. The performance must occur during a social function conducted by the Post.
- 4. The event must not be open to the general public it must be restricted to members and invited guests.
- 5. Any proceeds, after deducting reasonable costs for the performance, must be used for charitable purposes and not for financial gain.

To summarize:

- If your Post advertises an event to the public, sells tickets to the general public, or otherwise allows unrestricted public access, **the exemption will not apply**, and a license may be required.
- The exemption does **not cover businesses operating inside the Post**, such as canteens or restaurants that may play music for the general public.
- The exemption is limited to **live or recorded performances** of nondramatic musical works at qualifying private social functions.

The VFW remains committed to ensuring that our Posts operate in compliance with the law while keeping administrative burdens as light as possible. We encourage all Posts to take steps to understand and, where applicable, invoke the exemption under 17 U.S.C. § 110(10).

If you have any doubt as to whether you need to adhere to copyright laws, I draw your attention to the National Bylaws and Manual of Procedure, at Sec. 218, 418, 518, and 618 that requires Commanders to, "Insist that that the business and activities of the organization are conducted in such a manner that they do not violate any applicable governmental law, ordinance or regulation or bring or tend to bring dishonor or embarrassment on this organization." Copyright laws are applicable laws.

Recommendations

- Review your Post's music use to determine whether it meets the criteria for the exemption.
- If you receive a letter or invoice from a performing rights organization, do not ignore it. Evaluate whether your Post qualifies for the exemption and respond accordingly.
- When in doubt, consider consulting legal counsel or reaching out to the VFW National organization for guidance.

Development

June's revenue goal of \$4.3 million was not only met but exceeded by nearly \$400,000. We have four mailings remaining in this fiscal year, one of which mailed on July 1, with approximately 63,000 pieces sent to addresses in Texas.

Given the recent tragic event in Texas, we are closely monitoring the situation for potential impacts to donor response. In times of natural disaster, there is often a shift in donor focus toward immediate relief efforts, which can impact broader fundraising initiatives. The USPS will soon be providing a list of affected ZIP codes, which will allow us to better assess any implications for our remaining revenue projections.

On a positive note, we expect to realize approximately \$1 million in bequests before the close of the fiscal year, with an additional \$5.1 million projected for FY26. While the timing of estate gifts is subject to change for various reasons, these estimates are based on information provided by the law firm handling the VFW's estate cases, and they are upfront about their conservative forecasting.

Department Officer Proof of Eligibility

• With the start of Department Conventions, I want to remind everyone of the requirement to submit proof of eligibility for all newly elected Junior Vice Commanders and any elected Department Quartermasters or appointed Department Adjutants who are new to their position this coming year (2025-26).

Additionally, proof of eligibility is required for any new Department Commander or Senior Vice Commander, who for whatever reason were not in the line of succession the – previous year, to which we already have proof of eligibility on file.

This proof of eligibility must be submitted to the Adjutant General pursuant to Section 516 of the National Bylaws and Manual of Procedure.

This must be done <u>after</u> officers are installed and <u>prior</u> to National Convention and is most easily completed by sending documentation via email to Joseph Wolfgeher at <u>JWolfgeher@vfw.org</u>.

Information Technology

- Command Post Update:
 - o The development team provided an update on the project's progress, highlighting work on deployment, UI (user interface) components and backend systems. The team demonstrated the user interface design and discussed the technology stack being used for the project.
- Next steps:
 - o The development team is targeting to complete an initial deployment within the next couple of days, aiming to have something physically visible to see by next week.
 - o Troy is to ensure the member portal is branded correctly with VFW logos as it will use current VFW header and footer, not Command Post branding.
 - o The development team is working on the deployment process in the Dev environment, targeting completion this week. UI work has progressed with the completions on base person and entity data screens, as well as backend work on key setups and search preferences. The team is now focusing on editing profile information screens with APIs. Troy explains the structure of objects in the system, including person and entity objects. He demonstrates the user interface design in Figma, showing login, dashboard, search, and member record screens.

National Legislative Service

- Take Action to Keep Veterans in their Homes: On May 1, the Department of Veterans Affairs ended the Veterans Affairs Servicing Purchase (VASP) program, which offered veterans a "last-resort" option for the Department to purchase delinquent home loans. The program lasted only one year and was intended as an emergency stopgap to stave off veteran foreclosures after the COVID-19 moratorium lapsed. On May 19, the House passed Rep. Van Orden's bill without objection. <u>Take Action: Tell the Senate to pass</u> the *VA Home Loan Program Reform Act* and keep veterans in their homes.
- VFW Speaks at Roundtable with House Leaders: VFW National Legislative Service Director Kristina Keenan participated in a veterans organization roundtable hosted by House Minority Leader Hakeem Jeffries (NY-8) and House Committee on Veterans' Affairs Ranking Member Mark Takano (CA-39). The VFW has analyzed the budget needs through the annual report, <u>The Independent Budget</u>, and would like to have an opportunity to comment in a public forum.
- VFW Testimony on Subcommittee Pending Legislation: VFW National Legislative Service Associate Director Nancy Springer submitted a statement for the record for a

House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs hearing on pending legislation. The hearing reviewed 12 bills addressing issues including burial and survivor benefits, an annual report on veterans' causes of death, enhanced access to benefits for rural veterans, hiring preferences for Veterans Law Judges, and improvements to the VA claims and appeals processes.

 Press Conference on Care for Military Sexual Trauma Survivors: The VFW Washington Office hosted a press conference during which leading veteran organizations called on Congress to support <u>S.1245/H.R. 2576</u>, Servicemembers and Veterans Empowerment and Support (SAVES) Act of 2025. <u>Watch the press conference</u>, which begins at the 4:58 mark.
