## **Administrative Operations:**

- There are currently 70 Posts under suspension, 43 of which are CIC suspensions due to no election report. The organization has 5,611 chartered Posts.
- Administrative Operations is engaged in 12 Article IX Disciplinary Actions, three Administrative Removals/Actions and 10 membership eligibility challenges.
- Currently Administrative Operations has 184 Bylaws/Articles of Incorporation submissions in for review, seven of which are new.

# **Department Inspections**

- As the 2024-2025 term is getting started, the following 10 Departments have been identified and are tentatively scheduled for inspections. We are currently working on availability, scheduling and logistics with hopes that the first inspection will take place in early October 2024. Special orders will be sent to each Department with instructions on the next steps once they have been officially scheduled. Departments that have been identified for inspections are as follows:

### 2023-2024 End of Year Roll Up:

- Administrative Operations processed 262 total Post suspensions of which 155 were CIC suspensions due to no election reports for the 2023-24 & 2024-25 terms. There were 36 Post consolidations, 91 cancellation of Charters, and 13 new Posts processed and completed. Additionally, we issued 113 VFW Charters and 115 Auxiliary Charters for various reasons to include replacements, Post name or location changes, and Post consolidations.
- A total of 10 Department Inspections were scheduled and completed by the National Inspection team.
- A total of 107 Article IX Disciplinary Actions adjudicated: 63 officer removals, 22 518 letters, 87 eligibility challenges of which 73 were terminated due to ineligibility, four were found eligible, 48 voluntary resignations, 26 voluntary surrenders, and 13 reinstatements.
- 759 Bylaws and Articles of Incorporation have been received for review and approval during the 2023-2024 term.

- The VFW is expanding its Unmet Needs program to be more than just a request for financial assistance as it currently exists. The expansion will allow for the inclusion of all programs that veterans have unmet needs in, like our National Veterans Service that provides assistance to veterans filing disability claims which can dramatically change the lives of veterans and their families. Last year VFW Accredited Service Officers recouped \$11.2 billion for veterans.

### **National Legislative Service**

- Grand Opening of VFW Pre-Discharge Claims Hawaii Office: VFW National Veterans Service Director Mike Figlioli joined Chief of Force Development at the 647th Force Support Squadron Dr. William Kono, Joint Base Pearl Harbor-Hickam Commander Capt. Samuel White, and VFW Pre-Discharge Claims Representative Charles Tibbets for the grand opening of the VFW's newest pre-discharge claims office near Honolulu. - VA Dashboard Shows PACT Act Performance: In recognition of the second anniversary of the passage of the PACT Act (Public Law 117-168), VA has published a special issue of the VA PACT Act Performance Dashboard that shows statistics compiled over the past two years. Highlights include one million related claims VA has approved totaling \$6.8 billion, more than five million toxic exposure screenings, and an increase of nearly 186,000 new enrollees in VA health care.
