### **Administrative Operations**

- There are currently 73 Posts under suspension; five of which are new with eight suspensions lifted since last week. We are working to institute two and have instituted one new Post; we are working one Post consolidation; we have completed one and are working two charter surrenders; we are working three and have completed three charter revocations pursuant to Sections 201, 209, 210 and 212 of the National Bylaws. The organization has 5,806 chartered Posts.
- Administrative Operations is engaged in 16 Article IX Disciplinary Actions, 25 administrative actions and eight membership eligibility challenges.
- We have 10 Bylaws/Articles of Incorporation submissions in for review and received nine new submissions for the week. Current turnaround time on Bylaws/Articles of Incorporation submissions is approximately one week.

## National Legislative Service

- The president signed VFW-supported <u>H.R. 7846</u>, *Veterans' Compensation Cost-of-Living Adjustment Act of 2022* into law. Certain VA benefits including disability compensation, clothing allowances, and dependency and indemnity compensation for survivors will receive the same cost-of-living adjustment as Social Security benefits. The announced increase is to be 8.7 percent, which is higher than in recent years to account for inflation. The adjustment will go into effect on Dec. 1, 2022, and the first checks to reflect the new rate will be on Dec. 31, 2022. <u>Read more</u>.
- TRICARE has announced that on Oct. 24, 2022, thousands of community pharmacies will leave the network. Express Scripts is the TRICARE pharmacy contractor with oversight of home delivery, military pharmacy, and civilian contract facilities. Walmart and Sam's Club pharmacies are among those impacted by this change. It is recommended that you contact your pharmacy to see if it will remain in network or find a <u>participating pharmacy</u> near you. <u>Read more</u>.
- The VFW currently <u>supports 176 bills</u>; and <u>opposes one bill</u> pending before the 117th Congress.

- VFW's NVS Pre-Discharge representatives briefed transitioning service members on VA benefits at Fort Bliss, Texas, Nellis AFB, Nevada, Joint Base Andrews, Maryland, Joint Base Myer, Virginia, Joint Base Anacostia Bolling, D.C., and at the USO Transitions at Fort Hood, Texas.
- NVS leadership attended the VA Veterans Experience Office discussion on redesign of the TAP program.
- VAVS Volunteer of the Year nominations are being accepted by NVS health team until Dec. 15, 2022.
