Membership

Greetings from the Membership Department,

- This month we are making a push and emailing 5,544 annual members who are turning 31, 41, 51, etc., this calendar year, to consider upgrading to a Life membership as it will save them between \$15 \$65. We emailed 45,415 continuous other members that have paid dues for three consecutive years to consider upgrading to a Life membership. We emailed 214,262 Life members to consider becoming a Legacy member.
- Reminder that there is currently a Commander-in-Chief monthly challenge for February. The Post that leads its respective division in membership with a minimum of 2% growth in February will receive \$500. Any Department that has growth of at least 2% will also receive \$500.

Administrative Operations

- There are currently 36 Posts under suspension; eight of which are new with seven suspensions lifted since last week. We are working to institute five new Posts; we have completed one Post consolidation; we are working one charter surrender; we are working three charter revocations pursuant to Sections 201, 209, 210 and 212 of the National Bylaws. The organization has 5,757 chartered Posts.
- Administrative Operations is engaged in 21 Article IX Disciplinary Actions, 14 administrative actions and 10 membership eligibility challenges.
- In an effort to reduce paper and expedite our process, Departments are encouraged to submit Post, District, and Department bylaws and Articles of Incorporation to Administrative Operations via email to our Post Records Coordinator April Ferreira (AFerreira@vfw.org). Additionally, submitted bylaws or articles in conflict with the National Bylaws will be returned to the unit (Departments will be cc'd) with a list of amendments and a digital copy of our template for resubmittal. - A \$15,000 gift was recently received to support VFW programs from GovCIO, a veteran owned business consulting firm that focuses on cyber security, digital/data management, and IT services primarily for U.S. government agencies.
- A VFW Foundation Board meeting was held on Tuesday, Feb. 7, 2023, at VFW National Headquarters in Kansas City, Missouri. Issues discussed included additional VFW Board member nominations, VFW BURGER KING® Unmet Needs program updates, the use of eShow software to manage sponsors for the upcoming VFW National Convention in Phoenix, Arizona, the creation of a Foundation informational video, and a possible modification to the Foundation's vision/mission statement:
 - o New Vision Statement: "The vision of the VFW Foundation is to create a positive impact on America's military veterans, service members and their families by addressing their unique needs."
 - o New Mission Statement: "The mission of the VFW Foundation is to serve military veterans, service members and their families by securing resources for programs that facilitate enhanced life outcomes."

National Legislative Service

- The House Committee on Veterans' Affairs has announced its members. Rep. Mike Bost (R-IL), a Marine Corps veteran, will lead the committee as chairman. The former chairman, Rep. Mark Takano (D-CA) will assume the role of ranking member. The VFW has worked productively for years with both Chairman Bost and Ranking Member Takano in their previous roles, and we look forward to continuing that strong relationship. Other members of the committee, including many veterans, have been assigned to various subcommittee roles. Read more for a complete list of the members of the House Committee on Veterans' Affairs.
- Sen. Jon Tester (D-MT) has introduced VFW-supported S. 42, <u>BUILD for Veterans Act of 2023</u>. This legislation would streamline efforts to reduce the infrastructure backlog and improve the overall management of the capital asset programs of VA. "The <u>BUILD for Veterans Act</u> will require VA to develop and implement plans to remedy this infrastructure problem that has plagued VA for years," said VFW National Legislative Director Pat Murray. The bill is cosponsored by Sens. Patty Murray (D-WA), Sherrod Brown (D-OH), and Mark Warner (D-VA).
