- Phoenix convention housing opened Friday, Feb. 17, 2023, at 8:15 a.m. CST Housing assignments list and reservations link will be included on the Convention webpage www.vfw.org/Convention Note: NCOA members housing reservations will be made by National. - Sent housing notification memo to VFW Department Adjutants/Quartermasters copy to Department Senior Vice and Department Commander in advance with a reminder of housing opening on Feb. 17.
- Feb. 7, 2023, sent housing list and meeting resume (specifications) to Hyatt Regency Crystal City for upcoming Legislative Conference. The hotel immediately notified us our room block the night of March 8 was oversold. **Note:** Traditionally, a good number of attendees leave right after the Commander-in-Chief testimony. However, this year a large majority are staying until March 9. The hotel was unable to give us additional rooms on the night of the 8th.
- Secured overflow rooms for Legislative Conference at the Courtyard by Marriott (*adjacent*) to the Hyatt Regency Crystal City. The Courtyard by Marriott is offering same rate as the Hyatt (\$225 + tax) for those overflow rooms. Individuals moved to the Courtyard by Marriott will be notified. The hotel offers airport shuttle. *Note: NCOA are not part of this overflow group of rooms*.

Administrative Operations

- There are currently 36 Posts under suspension; eight of which are new with seven suspensions lifted since last week. We are working to institute five new Posts; we have completed one Post consolidation; we are working one charter surrender; we are working three charter revocations pursuant to Sections 201, 209, 210 and 212 of the National Bylaws. The organization has 5,757 chartered Posts.
- Administrative Operations is engaged in 21 Article IX Disciplinary Actions, 14 administrative actions and 10 membership eligibility challenges.
- In an effort to reduce paper and expedite our process, Departments are encouraged to submit Post, District, and Department bylaws and Articles of Incorporation to Administrative Operations via email to our Post Records Coordinator April Ferreira (AFerreira@vfw.org). Additionally, submitted bylaws or articles in conflict with the National Bylaws will be returned to the unit (Departments will be cc'd) with a list of amendments and a digital copy of our template for resubmittal. National Legislative Service

- The Senate Committee on Veterans' Affairs has announced its members. Sen. Jon Tester (D-MT) has returned as chairman, and Sen. Jerry Moran (R-KS) has returned as ranking member. The VFW has successfully worked with both Chairman Tester and Ranking Member Moran in the past, most recently highlighted last year by the historic passage of the PACT Act. Many other senators named to the committee also served on it during last Congress. Read more.
- The National Resource Directory (NRD) gives service members, veterans, family members, and caregivers the ability to find and connect with organizations that can assist with specialized recovery, rehabilitation, and reintegration needs. The NRD is the product of a partnership with DOD, VA, and the Department of Labor. This program is meant to facilitate free connections between individuals and stringently vetted resources that provide support in many areas such as employment, education, veteran benefits, caregiver support, housing, and the Military Adaptive Sports Program. - As part of the PACT Act, VA has expanded health care eligibility for certain veterans who were discharged after Sept. 11, 2001, and before Oct. 1, 2013. A one-year open enrollment period began on Oct. 1, 2022, for this group of veterans depending on their dates and locations of service, regardless of disability claim status. Once the open enrollment period has closed, veterans from this group will be eligible for VA health care as part of a phase-in process depending on discharge date. Apply today.

- NVS leadership will be monitoring the confirmation hearing for Josh Jacobs as the next Undersecretary for Benefits (USB) on Thursday, Feb. 16, 2023, in the Senate.
