Administrative Operations

- There are currently 36 Posts under suspension; two of which are new. We have instituted one and are working to institute one new Post. The organization has 5,745 chartered Posts.
- Administrative Operations is engaged in 28 Article IX Disciplinary Actions, 15 administrative actions and three membership eligibility challenges.

- We are processing election reports as quickly as we receive them. This is a reminder that the
 quickest and easiest way to submit election reports is by utilizing the Quartermaster's tools
 within the Online Membership System (OMS).
- To date we have received 2,319 Post election reports and 111 District election reports. Any Post that has not submitted an election report by June 1 is in arrears; will be prevented from voting at their respective Department convention; and will be subject to suspension/revocation.

National Legislative Service

- The House Veterans' Affairs Subcommittee on Health held a hearing on providing veterans access to life-saving substance abuse disorder treatment. Witnesses from VA answered questions on its policies and procedures regarding substance abuse treatment programs, wait times, and access to care. Subcommittee Chairwoman Miller-Meeks (IA-02) said, "Our country has been experiencing a substance abuse and overdose epidemic, we are seeing historic highs, and our nation's veterans are not immune. One death from substance use disorder is too many." Watch the hearing.
- President Biden signed an executive order that directs nearly every cabinet-level agency to expand access to care. The directives for VA include improving access to home-based care for veterans who require assistance with daily living activities, and consideration of expanding its Veteran Directed Care program to all 172 VA Medical Centers by the end of fiscal year 2024. This program is a vital resource for certain veterans who require support due to their service-connected injuries or illnesses. Read the executive order.
- The VFW-championed Global War on Terrorism Memorial Location Act that became law in 2021 authorized its construction on the National Mall in Washington, D.C. The National Capital Planning Commission has now authorized the Global War on Terrorism Memorial Foundation to begin designing the memorial for the Site A location, which is situated north of the Lincoln Memorial between the Vietnam Veterans Memorial and the site of the future National Desert Storm and Desert Shield Memorial. The Foundation is now able to proceed to steps 13-19 of the 24-step memorial construction process after being in steps 9-12 since August 2017.
- Established in May 2022, the Suicide Prevention and Response Independent Review Committee (SPRIRC) recently released its report following a comprehensive review of related DOD programs. The SPRIRC, which is comprised of ten subject matter experts, visited nine domestic and overseas military installations and spoke with nearly 3,000 stakeholders including service members and families, civilian personnel, and representatives from the military and veteran community. It concluded that the limited response to date to suicide within DOD has resulted in persistent elevated rates, and SPRIRC made 127 recommendations for DOD to review and act upon. Secretary of Defense Lloyd Austin subsequently released a memorandum outlining the Pentagon's next steps and planned actions to address the report findings. Read the SPRIRC report.
