We hope you enjoy this week's National Council Weekly Update on the pertinent happenings of your VFW departments.

#### **Quartermaster General**

We have experienced a significant increased demand for "Buddy" Poppies this year. The pandemic forced many of our assembly centers to close permanently, forcing us to obtain the assistance of a local nonprofit organization to meet production demands. Unfortunately, the process of outsourcing assembly forced us to pass the increased cost of assembly onto the consumer. Using average annual demand numbers, our original forecasts projected the increase would not need to occur until the start of the new program year on July 1, 2023. However, increased orders this year rapidly depleted the supply of poppies we had in stock that were manufactured by those assembly centers.

Effective April 15, 2023, the cost of the Buddy Poppy will increase to .25 cents per poppy. 500 quantity orders will be \$125 plus shipping, and 1,000 quantity orders will be \$250 plus shipping. All orders will continue to be processed as normal through the VFW Programs office <a href="mailto:buddypoppy@vfw.org">buddypoppy@vfw.org</a>. The National HQ <a href="mailto:will not">will not</a> derive any additional revenue from this increase. This amount reflects the cost of goods, the cost to assemble, the share mandated by the national bylaws for the VFW National Home and for National Veterans Service. Anything less would cause a financial loss to the organization.

# Future way ahead:

- We've asked the Tin-Tab Buddy Poppy vendor to step up production so we can have this option available by Sept. 1, 2023, at a cost of .10 to .12 cents per poppy (exact price TBD).
- The new Tin-Tab Poppy will not immediately replace the traditional Buddy Poppy.
- Department Quartermasters will have the ability to place poppy orders through OMS effective July 1, 2023. We will communicate the process and/or changes to the process in the weeks leading up to July 1.
- Once the order process migrates to OMS:
  - o Credit for purchases will be given through dashboard nightly.
  - o Reconciliation of Department inventory will continue through OMS.

- o Tracking of orders will be available through the Member Service Center (MSC).
- o Orders will be processed and arrive at your address much guicker.
- VFW Programs Director Lynn Rolf will be available for Q&A at the upcoming SVC Training Conference in April.

- There are currently 32 Posts under suspension, four of which are new. We have processed one Post consolidation pursuant to Section 209 of the National Bylaws. The organization has 5,744 chartered Posts.

#### **National Legislative Service**

- VFW National Legislative Service Director Pat Murray testified on pending legislation at a House Veterans' Affairs Subcommittee on Economic Opportunity hearing. In regard to the importance of proper oversight of the TAP program Murray stated, "While we know it is not the role of this committee to ensure TAP is properly administered, we urge Congress as a whole to make sure it is being done." Watch the hearing or read the testimony.
- VFW National Legislative Service Deputy Director Kristina Keenan testified on pending legislation at a House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs hearing. The bills included H.R. 1139, *Governing Unaccredited Representatives Defrauding VA Benefits Act*, known as the *GUARD VA Benefits Act*, which is one of the VFW's top legislative priorities. It would reinstate penalties for charging

veterans and survivors unauthorized fees related to claims for VA benefits. "Currently, these predatory companies have no accountability, no oversight, and no penalties," said Keenan. "If they were genuine in providing veterans with more choice, they would choose accreditation and offer quality services that are transparent and legal." Watch the hearing, or read the testimony.

• The House Veterans' Affairs Subcommittee on Health held a hearing on pending legislation. Representatives from VA answered questions on its policies and procedures regarding long-term health care services, increasing the number of patient advocates, and appropriate notifications for detailed positions. VFW National Legislative Service Associate Director Meggan Thomas submitted a statement for the record. Regarding H.R. 542, *Elizabeth Dole Home Care Act of 2023*, Thomas commented that the VFW continues to advocate for long-term care options as stated in our legislative priority goals and resolutions, which is why we support this proposal.
