#### Administrative Operations

- There are currently 35 Posts under suspension; one of which is new with three suspensions lifted since last week. We are working to institute one new Post; we have completed one and are working one Post consolidation pursuant to Sections 201 and 209 of the National Bylaws. The organization has 5,743 chartered Posts.
- Administrative Operations is engaged in 25 Article IX Disciplinary Actions, 14 administrative actions and eight membership eligibility challenges.
- We are processing election reports as quickly as we receive them. This is a reminder that the quickest and easiest way to submit election reports is by utilizing the Quartermaster's tools within the Online Membership System (OMS).
- To date we have received 2,428 Post election reports and 121 District election reports. 3,315 Posts, or 57%, still have not submitted an election report. Any Post that has not submitted an election report by June 1 is in arrears; will be prevented from voting at their respective Department convention; and will be subject to suspension/revocation.

### National Legislative Service

- The House passed a budget resolution to reduce the amount of federal spending for the next fiscal year (FY). The resolution sets overall spending at 2022 levels but does not specify that veteran care and benefits would not be reduced. VFW Washington Office Executive Director Ryan Gallucci sent a letter to Speaker of the House Kevin McCarthy urging him to ensure protections for veterans are addressed. Gallucci wrote, "Plainly stated, the Honoring our PACT Act of 2022 did not exist when funding levels were set for FY 2022." The PACT Act was not passed into law until after budget levels had been established, so the VFW wants to ensure the monumental advances secured through that legislation are protected. Read the letter.
- The Senate Committee on Veterans' Affairs held a pending legislation hearing to discuss 14 bills on veteran and survivor benefits. VFW National Legislative Service Deputy Director Kristina Keenan provided a statement for the record in support of these proposals. In particular, she conveyed the VFW's strong support of the GUARD VA Benefits Act of 2023, which would reinstate criminal and financial penalties for unaccredited representatives who prey on veterans. <u>Read the testimony</u> or <u>watch the hearing</u> that begins at the 11:48 mark.
