

Grand General Order #1 of South Carolina Military Order of the Cootie 2023 to 2024

GENERAL ORDER # 1 - 24 June 2023

1. Having been duly elected and installed as Commander of the Grand Pup Tent of South Carolina of the Military Order of the Cootie at the Grand Council of Administration and Election of Officers' convened at 10154 Bellwright Rd., Summerville, S.C. (hosted by PT# 10). On 03 June 2023:

" I, Betty Hilliard, do hereby assume the command of the Grand of South Carolina, Military Order of the Cootie of the United States."

2. All previous appointments are now expired, except for those duly Elected or Appointed.

3. All Pup Tents are required to insure they are in compliance with IRS Regulations and submit IRS Form 990. If you have any questions, contact your VFW Post Quartermaster for guidance and assistance. All Pup Tents must have "an EIN NUMBER" even if you do not have employees. (EIN's are obtained from the IRS)

4. All General Orders and Official Correspondence must be read at Pup Tent regular scratches

5. Quarterly Tight Wad reports of audit must be submitted by the 15th day of the month following the end of the quarter to the Grand Quartermaster.

6. All Seam Squirrels - by virtue of their position, and all Past Grand Commanders, are members of the "C OF A" - the Council of Administration.

7. Each Pup Tent must register "at least ONE" Cootie for the Grand and Supreme Scratches. Any Pup Tent not registering at least ONE delegate for either Scratch will be considered in arrears and will lose voice at both Scratches.

8. Having been duly elected by the Grand, and installed by Supreme Adjutant Tracy Woodman - the following Elected and Appointed Officers of the Grand Pup Tent of South Carolina shall be afforded all due recognition and are empowered by this General Order to become familiar with, and to perform the duties of their individual offices:
