\*\*\*In 2021 there were more than 8,000, military-on-military, sexual assaults reported to DoD. In 2016 DoD and the VA started a more earnest program to track and treat Military Sexual Trauma (MST). Since 2016 about 38% of female and four % of male veterans have reported experiencing MST.

As of August 2022 there were 26,000 pending MST claims with the VA. The average claim processing time is 136 days. The VA now has 120 claims officers that are specifically trained to handle MST claims.

The VA wants any person who filed an MST claim before August 2018 and you received a denial from the VA, to re-file your claim. The VA is working on a backlog of 9,700 previously denied claims that they are re-opening and re-evaluating with claims officers now trained in MST issues.

Persons wishing to re-file should contact an MST Outreach Coordinator at your local VA Office or online at <u>https://www.benefits.va.gov/benefits/mstcoordinators.asp</u>

Or you can call a VBA Outreach Coordinator at 800-827-1000 If you have it, you may submit additional evidence with your claim.



VA Sexual Assault and Harassment Report Hotline: Veterans can now call 1.800.MYVA411 (1.800.698.2411, option 9) to report sexual assault or sexual harassment at VA facilities. The call center is available twenty-four hours a day, seven days a week. Veterans, their families, caregivers, and survivors are also encouraged to report

any incident of sexual harassment or sexual assault as soon as it occurs while still at the VA facility. These incidents can be reported directly to VA police, VA staff, local law enforcement, or by calling the hotline.

#### **RECOGNIZING SOME S.C. PRISONERS of WAR (POW)**

Back in April when your new Commander Jim Fox and new Chief-of-Staff Ginger Graham had other titles and positions, they attended a get-together for two S.C. POW's. Commander Fox was so impressed with this outing that he is planning a POW/MIA recognition day event on

September 15<sup>th</sup>. There are currently 10 former POW'S living in S.C.. Commander Fox is hoping to get them all to attend.

During the organized April visit in Summerville, Commander Fox and Chief-of-Staff Graham met with F-4 back-seaters Dick Vaughan and Rick McDow (Mr. Vaughan, left & Mr. McDow, right).



McDow was in F-4 Phantom II Combat Crew Training from May 1971 to January 1972. His first assignment was as an F-4 Weapons System Officer with the 390th Tactical Fighter Squadron at Da Nang AB, South Vietnam, from January 1972 until he was forced to eject over North Vietnam and was taken as a Prisoner of War on June 27, 1972. After spending 275 days in captivity, Lt McDow was released during Operation Homecoming on March 28, 1973

Dick Vaughan completed Undergraduate Navigator Training and was awarded his navigator wings at Mather AFB, California, in January 1971, followed by Weapon Systems Officer (WSO) training and F-4 Phantom II Combat Crew Training at George AFB, California, from January to September 1971. He served as an F-4D WSO with the 555th Tactical Fighter Squadron at Udorn Royal Thai AFB, Thailand, from October 1971 until he was forced to eject over North Vietnam and was taken as a Prisoner of War on December 18, 1971. After spending 467 days in captivity, Lt Vaughan was released during Operation Homecoming on March 28, 1973.

**VA HEALTHCARE RECORDS** – In case you are not aware. The VA is in the process of putting all of your health care records on a singular electronic file (Electronic Health Records-EHR) where they can be easily accessed by not only the VA but any of your other medical providers. Right now they have five locations operating in the country under this system.

In April, the VA put a halt to further installations because of a "reset" of the system improvement priorities in the current five locations and future locations.

The VA has not said when or if they will continue the installation of this planned VA wide electronic record keeping system.

#### The PACT ACT and Post 9-11 Veterans

The one-year special health care enrollment period for post-9/11 combat Veterans began October 1, 2022.

You may already know the **PACT Act** expands **health care eligibility** for many Veterans. One group that may be eligible for expanded benefits are **post-9/11 Veterans**. A one-year special health care enrollment period for post-9/11 combat Veterans began on October 1, 2022. Help spread the word before the special enrollment period ends.

#### Post-9/11 Veterans health care eligibility

If you meet the requirements below, you can enroll in VA health care before October 1, 2023. To be eligible, one of the following must be true:

\*You served on active duty in a theater of combat operations during a period of war after the Persian Gulf War, **or** 

\*You served in combat against a hostile force during a period of hostilities after November 11, 1998

And both of these must be true:

\*You were discharged or released between September 11, 2001, and October 1, 2013, **and** \*You haven't enrolled in VA health care before

Post-9/11 Veterans discharged or released on or after October 1, 2013, are not subject to the special enrollment period but can enroll within 10 years of their separation or discharge date. Review **more eligibility requirements** on VA.gov.

We encourage Veterans to apply, no matter their separation date. Your eligibility depends on your service history and other factors.

#### My HealtheVet and your health care

If you're already enrolled in VA health care and have questions about what the PACT Act might mean for you, VA can help. <u>Sign-in</u> to your <u>Premium</u> account and send a <u>Secure</u> <u>Message</u> to ask who you can talk to about the the PACT Act. With My HealtheVet, you can also <u>view and organize</u> your health information, like your providers and closest <u>VA facility</u>.

NOTE: As of the end of April, the VA announced that Veterans and their survivors have filed more than 500,000 claims for toxic exposure-related benefits under the PACT Act since President Biden signed it into law Aug. 10, 2022. To date, VA has awarded more than \$1 billion in earned benefits to Veterans and survivors who filed PACT Act-related claims.

#### Membership Transfers – Are you doing it by the book (Article I, Section 107, Transfers)

As part of a member transfer acceptance. To assure the perspective transfer member is leaving their old post with no financial or other obligations. Your Post should have available to sign and the perspective new member must make the following written declaration :

I hereby certify that it is my desire to transfer my membership. I further certify that I am not indebted to my former Post, be it through oral or written commitment or otherwise, and that, to the best of my knowledge, no written charges have been preferred against me by my former Post and I understand that any such indebtedness or charge which may be disclosed anytime thereafter will render this transfer null-and-void.

Member should surrender old post ID Card to accepting Quartermaster.

#### **\*\*DO YOUR MEMBERS KNOW WHAT IS GOING ON\*\***

I once queried a Post Commander on how his membership was getting the word on what was going on at the Post. His response was "if the members want to know what's going on at the Post, they should attend the meetings". To me, this was a very poor response. With only 3 to 10% of a Post membership and less than a 4% of a District membership attending a Post or District meeting. HOW do the rest of the members know what is going on?

I know of Post and District Meeting Minutes that are produced right before, and distributed only for the next meeting. So, the only people who see the minutes are those members who were at that last meeting and were part of the minutes. What about the other 90 to 96% of your membership?

Some Post Commanders say their calendar spreads the word. But, does the calendar say anything about the success of your Poppy drive? Does it tell of the success of your Blood Donor drive? Does it tell everyone where your membership stands and what it is going to take to get to your Post membership goals? Does it tell of the food drive your Post held for homeless veterans?. I THINK YOU GET THE POINT.

You have to have minutes from your meeting. Why not get them done within 1 week of the meeting. Then post them on your Post Bulletin Board, Post Bulletin, Website or Facebook page, or Newsletter (if you have one). Districts should do the same thing and the District Commander should mandate that each Post in their District distribute District meeting minutes within one week of the meeting.

I have always maintained that the #1 reason for loss of membership is ...the lack of COMMUNICATION at all levels of the State VFW. Both, between the newer members and their Posts and the Posts and Districts failing to connect with the majority of their memberships. SENTINEL Editor

**Membership Eligibility** – You have a potential new recruit and in checking their potential eligibility, you see their DD 214 states they have the Air Force Expeditionary Service Medal. There are 3 versions of this medal.

If you check page 63 of the Manual of Procedure, a person is only VFW eligible if the ribbon has the GOLD BORDER. If you look up this medal, you will see that only the GOLD BORDER means that person served in a COMBAT ZONE <u>AND</u> received HOSTILE FIRE pay.

### **Does TRICARE Cover Care When Traveling Overseas?**

FALLS CHURCH, Va. – Exploring different countries and cultures is exciting. As you plan your trip, you may have some questions about what coverage TRICARE offers when you travel overseas. It's important to prepare for your trip with your health care in mind.

"While traveling overseas, the rules for getting care depend on your sponsor status, your health plan, and your location," said Michael Griffin, program analyst with the TRICARE Overseas Program Office at the Defense Health Agency. "Being prepared to seek health care while traveling is as important as packing the right clothes for your trip. You should know your options for accessing care overseas, as well as what you'll need to do when you return home."

The following questions and answers will help you prepare for your trip and learn how to get health care overseas if you need it.

Q: Does TRICARE cover me if I need emergency care?

A: Yes. If you reasonably think you have an <u>emergency</u>, call the emergency number of the country you're in, or go to the nearest emergency room. The TRICARE Overseas contractor, <u>International SOS</u>, provides 24/7 support if you need urgent or emergency care. <u>Choose the country</u> where you're located for a list of contact numbers, including the Medical Assistance number.

If you're admitted to the hospital overnight, notify the <u>TRICARE Overseas Program Regional Call</u> <u>Center</u> within 24 hours or on the next business day. After you return home, contact your health care provider, as you may need follow-up care.

Under certain circumstances, TRICARE may cover air evacuations.

#### Q: What should I do if I get sick on my trip?

A: For medical conditions that aren't emergencies but need professional attention within 24 hours or any other nonemergency care, active duty service members must seek care at military hospitals or clinics when possible. Everyone else should follow their health plan's <u>rules for getting urgent care overseas</u>. If you need to quickly find a provider overseas, use the <u>provider search tool</u> or call <u>International SOS</u>.

If you need medical advice, the <u>Military Health System Nurse Advice Line</u> might be an option. It's a free service available outside the United States in any country with a <u>military hospital or clinic</u>.

Remember that whatever type of health care you receive, you may need to pay up front and file a claim with the <u>overseas claims processor</u> to be reimbursed. Be sure to keep all receipts associated with your care.

Q: Can I refill a prescription overseas?

A: If you must fill prescription while traveling, remember:

<u>Military pharmacies</u> are an option if one is close by.

<u>TRICARE retail network pharmacies</u> are only located in the United States, Puerto Rico, Guam, the Northern Mariana Islands, and the U.S. Virgin Islands. As outlined in the <u>TRICARE Pharmacy Program</u> <u>Handbook</u>, if you go to an <u>overseas pharmacy</u>, be prepared to pay for your prescription up front and <u>file a</u> <u>pharmacy claim</u> with the overseas contractor for reimbursement on covered drugs.

Q: Do I need to purchase additional travel health insurance?

A: No, but it's a personal decision. If you're considering buying extra health insurance, keep in mind that all private and travel insurance policies pay before TRICARE. If you get care while traveling overseas, you'll need to file your claim for reimbursement with your travel insurance first. Then <u>submit the claim to</u> <u>TRICARE</u>, along with the explanation of benefits from your travel insurance provider for the care you received.

Q: What else should I do before I leave on my trip?

A: TRICARE suggests several items to put on your pre-travel to-do list:

\*Before you leave check that your personal and contact information is up to date in the Defense Enrollment Eligibility Reporting System (DEERS). If your information is incorrect in DEERS, it could affect your TRICARE coverage.

\*Get any routine health care needs completed before traveling overseas.

\*Refill your prescriptions before traveling. If you tell your doctor about your upcoming travel, they can authorize up to a 90-day supply. Pack your prescriptions in your carry-on bag so you'll have them with you if your luggage is delayed or lost.

\*Depending on where you're traveling, check with your doctor to ensure you're up to date with all necessary <u>vaccinations</u>. Call well ahead of time so you can schedule an appointment and get vaccinated prior to your departure.

\*Download the <u>TRICARE Contact Wallet Card</u>. It lists the numbers to use if you need health care services or support when traveling.

Used in REGULATIONS and DIRECTIVES to express what is MANDATORY.

YOUR Manual of Procedure, National and State By Laws are full of instances where the word SHALL is used.

Unfortunately; there are Districts and Posts within our state and I would imagine every state and territory that a VFW exists, that do not comply with many of the 'shall's' in these documents. EXAMPLE: State by Laws ARTICL E IV, Section 1 states that Posts and Districts have to attend State Conferences and Conventions. To be legally represented, that means that at least the Commander, Sr or Jr Vice must attend for the Post /District to get credit for attending and to be able to vote. Sending your Adjutant, Quartermaster, Trustee or anyone not listed above. Means your post is not legally represented and not eligible to vote on any issue or election AND does not get credit on the State Report Card

#### Your State By Laws

\*Article IV, Sec 1 states that at least one Commander, Sr Vice, Jr Vice SHALL attend the Department Conference and Convention. Only these positions have the authority to vote during a Department Convention or Conference.

You can't send your Quartermaster or a member to give your post credit for attending, or for participating in the voting process.

**BOTTOM LINE** – SHALL means it is NOT optional and compliance is expected.

**Are you still writing checks to pay bills or send someone money?** The U.S. Department of the Treasury Financial Crimes Enforcement- Network wants you to stop writing and start going paperless. Here's why:

\*Check fraud has doubled in the last year to over 680,000 cases reported.

\*In 2021 the US Postal service received over 300,000 cases of reported check theft in the mail. In 2022 it rose to just short of 400,000 cases.

\*Check thieves also use your check info to make fake Identification, open credit lines and in some cases even start a small business.

If you have to write checks the Treasury Dept. recommends using a "Security Pen" who's thick/adhesive ink makes it almost impossible to wash-off or erase. **The Uni-Ball 207 Series pen is recommended.** 

#### \*Also, DO NOT put your Phone Number or Social Security number on a check.

\*The post office recommends only putting checks in a Post office Mailbox, NOT your home mailbox

Thefts through paperless check sending are almost non-existent. Your bank can show you how to do this.




