*****URGENT**: If you are an "Annual dues paying member"? Your membership 'anniversary date' is the date you joined the VFW as a member in good standing, not January 1st. If you do not renew your membership by your ANNIVERSARY DATE? The day after, you cease to be a member in good standing and lose all rights of membership.

<u>This is critical in that</u>....If you are an elected or appointed official at the Post, District or Department level. You LOSE that position (the day after your dues expire). VFW BY-LAWS, ARTICLE I, Section 105

Are you aware - That VFW National currently supports over 100 Bills that are before Congress?

MIA'S Coming Home – In 1950, when the Hawaii "Punch Bowl" Cemetery opened. 394 Sailors and Marines who died at Pearl Harbor were buried in the Punch Bowl. They were of a group

who's remains could not be identified. Recently, due to modern forensic technology, 338 of that 394, that served on the USS Oklahoma, and died, buried at the Punch Bowl, were identified.

I DID SOME RESEARCH and DID YOU KNOW THAT – VFW POST # **1** Is located in Denver, Post **2** in Philadelphia, Post **3** Altoona, PA, Posts **5** & **7** in Minnesota, Post **9** in Maine and Post #**10** in North Carolina. Posts 4, 6, 8 no longer exist, nor do about ½ of the original 50 posts. The earlies Post in Europe is #27 (Wiesbaden Germany, 1977, over 2,500 current members). ALSO – Did you know New York's District 1 has **82 Posts** in that District? How would you like to

be the Commander of that District?



I made it to VFW Post 1 in September, but unfortunately, it was closed for renovations due to asbestos problems.

+++LOOKING TO RECRUIT A NEW MEMBER? Why not take it a big step forward and try to recruit a new post? – Sound like an impossible task? Well, really, it's not when you look at the number of big towns and some counties in SC that do not have a VFW presence.

The biggest hurdle in trying to establish a new post is – WHERE DO THEY MEET? – A post needs someplace to call home. Even if it is just once a month for the monthly business meeting. So, before you go out looking for new members. It would be a good idea to scout the town and see what business, or other organization, has the space and might be willing to allow a monthly VFW meeting. A good place to start here is the local Chamber of Commerce. Then there's the American Legion's, Elks, Moose, the County Services building, etc. While you're recruiting these new members. See if they know of any place suitable for a monthly meeting. Keep in mind that a new post does NOT need to have a canteen/bar/kitchen to be successful. It needs members willing to carry-on the VFW tradition of service for veterans, including themselves.

How do you prep for a new post recruiting event?

*First off, make sure you have a VFW, NEW POST STARTER KIT. It has all the things you need to get started. The kit costs \$55 and if your post does not have the money, I'm sure you can get your District or the State to donate the purchase.

*You should have a Membership recruiting Kit \$38.50

*And, if you're fortunate enough to succeed in putting together a new post? You'll need a new Post Charter Kit (\$310) that contains everything necessary to start/hold your monthly business meetings. Including putting together your new post charter for state and national to sign off on. *Work with the local newspaper at least one month in advance to promote a recruiting drive. ++Most newspapers will publish this for free in their "Community News".

++f there is a local radio station that encompasses the town/area you are trying to start a new post. Work with them, they will freely advertise a 'recruiting/new post' meeting event.

*Post "New Post Recruiting Drive" flyers in businesses throughout the area.

IMPORTANTLY; Seek the help, of not only your post, but nearby posts, your district and the state. All will chip-in to help the creation of a new post become a reality.

DO YOU VOLUNTEER? - HERE'S SOMETHING FOR YOU TO THINK ABOUT

There are many of us on the VA Disability List. Many of us like to do volunteer work for veterans and this includes being a VA Volunteer Services volunteer. **IF YOU ARE CLASSIFIED AS 100% DISABLED?** This implies an inability to work (paid or volunteer). If you are a VA volunteer, you're personal information (including your SS #) is on file with the VA. This includes the number of volunteer hours you put in in a month.

If you volunteer numerous hours (I know several who put in over 25 hours a week) this is a matter of record. The VA Disability section has access to this information. If you are classified as 100% and working (volunteering) numerous hours. The VA has the authority to reduce or take away your VA Compensation. I know of a couple of persons who have lost/had reduced their disability rating because of this.

NOTE: The same thing goes if you are working numerous paid hours for anyone outside the VA. Your SS# is on file, and the same logic applies as above.

NOTE 2: I am a registered/trained VA Volunteer, but I carry a ZERO HOURS worked balance on my VA volunteer sheet. This, even though I do various projects for my local VA Clinic.

DID YOU KNOW – That at the height of the Mayan civilization, they played a game with teams that was similar to basketball. Two teams trying to throw a stone, ball-shaped, thing through a rock with a hole in it.

The Veterans Health Administration is the largest healthcare network in the United States and is made up of 1,243 health care facilities; 172 of which are VA medical centers, and 1,062 are outpatient sites with varying purpose. Among these sites are VA outpatient clinics, community-based outpatient clinics, community service programs, Vet Centers, and domiciliary care centers. These facilities are divided based on geographic location into 18 Veterans Integrated Service Networks (VISNs).

VFW SC Council of Administration – October 2021

The 4th quarter (2nd quarter in VFW years) started off with YOUR Department holding a Council of Administration meeting in early October. Most of the council was there to brief on what's happening in their VFW world. There were also a couple of delayed All American presentations and a couple of other awards/recognition given to post commanders or their representatives and one particular Auxiliary President.

Walgreens was present to provide flu and COVID shots, free of charge, to anyone who wanted one (Thank you Natalie Reynolds and Ashley Merritt). Representatives from Humana were on hand to provide an update on the good things Humana is doing in support of all our veterans (Thank you Alan Eden and Robert Elwood).

My brief summary of meeting events:

*Report of Investigation – When there is a problem at any level of the state VFW, perceived or actual, an investigation is initiated. Depending on what happens at the level of investigation. The matter, if found valid, is attempted to be resolved at the lowest level. If not possible ,it goes to the District or State Commander, or even the National offices may get involved to resolve the issue. The nature of resolution depends on the level of cooperation from the VFW entity at fault.

EX: Two posts were found to be operating a canteen without a liquor license or bonding for paid employees. They both lost their VFW Charter because this was an ongoing offense. *Budget and Finance Committee reported some minor discrepancies in their latest audit. Will be corrected.

*The National Council Member reported that a Quartermaster was knowingly and willfully certifying members for their VFW Post that were not eligible, in order to meet membership recruitment goals. This included members elected to positions in the post.

*The National Legislative Chairman advised everyone to keep on their Congressman in regards to veteran retirement income not being taxed by the state. He also advocated support for the SC Veteran Coalition Organization.

*The Conference and Convention Chairman reminded all of the upcoming *Mid-Winter Conference, 17-20 February at the Doubletree*

*The Southern Conference Chairman reported room occupancy for the conference was well above the required quota.

*Commander Hora reminded all that they need to send their veteran support projects to the Veteran and Military Support Chairman

*The Teacher Awards Chairperson provided an update on recognition submission time-lines *The VOD/PP and State Awards Chairperson provided an update on recognition time-lines and a reminder to consider those that are doing good things for their posts to be considered for state awards

*The Department Editor reminded all that Post Newsletter Award submission are due to him by the end of December. Still time to submit your newsletters for submission.

*A representative for the Membership Committee reported the state at 81.6%

*Each District Commander/Representative gave an update on their District activities.

*The Immediate Past State Commander reported the newest Post (12207) was at 200+% membership and was currently #3 in National Division 11 membership. WAY TO GO!!

ARE YOU READY FOR THE FINAL EVENT IN YOUR LIFE?

If it is your intention for you, the veteran, and your spouse to be buried in a VA National Cemetery? There are many things you need to know.

The VA has an amazing package that takes you through every step of your transition from this life. It explains everything and allows for your post-life planners and surviving relatives to efficiently and effectively cover every aspect of funeral planning.

The package is called **PLANNING YOUR LEGACY** – <u>The VA Survivors and Burial Benefits Kit.</u> It can be found as simply as going to the VA website.

Many of us South Carolinian's are transplants from other states. Many of us may want to be buried in a National Cemetery in our original home-state, or where most of the family resides. There is a caution here, in that even though the VA has 155 National Cemeteries in the US and Puerto Rico. There are eight (8) states that do not have a National Cemetery. Just go to the US National Cemeteries website to find out where.

**For anyone looking at being buried at Arlington? This is NOT a US National Cemetery. It is run by the Department of the Army and you must contact Arlington directly for information and burial eligibility. Go to https://www.arlingtoncemetery.mil or call 877-907-8585.

****Want to be buried at sea?** – The US Navy still does this. The only draw-back is that the ceremony takes place at sea during a deployment. Therefore; no family members can be present. The Navy will send, to the designated survivor, the date, time and geographic coordinates that the ceremony actually took place.

To get a request kit, contact Navy & Marine Corps Mortuary Affairs at 1-866-787-0081 or go to the US NAVY Burial at Sea website.

NOTICE – That I did not say you had to have been in the Navy. The burial-at-sea is open to **ALL** branches of the US Military and select other areas.

THE VFW AND YOU HOT-SHEET

***During the National Convention, the Rules and By-Laws Committee made some changes to the 2022 Podium Book. One of those changes is that Districts and Posts are now allowed to conduct their meetings electronically. At the start of the pandemic and over the last year and a half, electronic meetings were implied as being allowed in order to keep a District or Post meeting as required by VFW By-Laws. Now, there is no reason for a District or Post to not comply with meeting requirements. Naturally, The VFW would like to see Districts and Posts meet in person, but the VFW understands the fears and restrictions that are still in play in regards to COVID safety requirements.

NOTE: These "VIRTUAL" meetings are now a way of life within the VFW. An example is that the FALL NATIONAL LEGISLATIVE CONFERENCE was held in September. It was completely electronic and was 'electronically' attended by representatives from all 50 VFW Departments.

If your District or Post does not have electronic meeting capability. You need to establish a ZOOM or Face-Time account, or whatever electronic meeting capability currently exists, or may develop in the near future,

*****Partners in Patriotism** – Tired of all the VFW mail and email asking for help, but you still want to do your part in supporting YOUR VFW? The VFW has a program called **PARTNERS IN PATROITISM** that allows you to set-up a scheduled donation system that can be in effect as long as you want. You can donate on a monthly basis for as little as \$10 a month with the donation coming from your Credit Card or an Electronic Funds Transfer (EFT) from your bank account. Besides helping your fellow veterans, the good thing for you is that you now receive only a VFW QUARTERLY Supporter newsletter and an end of year Tax Receipt.

*****Burn Pits** – There is a new presumptive list for BURN PIT claims! You must file your claim within **10 YEARS** of separating from service and you must have served in Southwest Asia from August 1990, or Afghanistan, Syria, Uzbekistan and Djibouti from September 19, 2001 to present.

The three new symptoms are **ASTHMA**, **RHINITIS and SINUSITIS.** There are also possible secondary issues developed from these disabilities that can also be claimed. If you feel you have a claim? You need to contact your nearest Veterans Service Officer to file.

*****MENTORING** – One of the reasons new members don't stay members, or don't get involved with YOUR Post activities. Is that they don't know what's going on, or more importantly. What the VFW is all about and specifically, what YOUR Post VFW is about. It is imperative that for any new member who attends their first meeting, or comes by the Post, that they be heartily welcomed and be provided someone who can explain the VFW and their Post to them. Any new member approval at the post meeting should automatically be assigned someone from the post who will voluntarily assume the responsibility of MENTORING that new person. Even if that person has to be the Post Commander.

Most new members are approved at the business meeting and they are NOT present. It is EXTREMELY important that some sort of communication goes their way (email or snail-mail) welcoming them to the post. Asking if they have any questions? Providing them with a list of upcoming activities (like a monthly post calendar) and providing the name and means of communication of a post member who will help them get introduced to their new post. Don't do things like saying 'welcome to the post', would you like to be our next Jr. Vice-Commander! That is a TURN-OFF.

FOR ALL YOU OLD and NEW ARMY VETERANS – Did you know that the Army actually had a regulation that required the naming of all its equipment? Did you also know that within this regulation was a section that required that all aircraft be given "Native American terms and names of tribes and chiefs? That's how the UH1 "IROQUOIS" ('Huey') helicopter got its name. This also went for the H-13 SIOUX (in the 1950's), the UH-72 "LAKOTA" (in 2008). In 2012 Lakota Elders bestowed ritualistic blessings on the Lakota helicopters. OH YEAH! The Army Regulation was AR 70-28, established in 1969. It was eventually replaced with the new Army policies that did not mention the Native American criteria. However; the naming tradition has continued over the years.

In case you did not see this A CHANGE IN TRICARE PHARMACY PROVIDERS

As of December 15th, Walmart and SAM'S Club were NO LONGER a part of the TRICARE Pharmacy network as a pharmacy provider. CVS took its place. Walmart was a provider for three years, but TRICARE cited the retail giant's reluctance to offer more highly competitive discounts to military health beneficiaries. CVS returns to TRICARE after a five year absence. Walmart/SAM'S have 5,300 locations nationwide. CVS has 10,000.

CONGRATULATIONS – To Comrades James Beaty and Rodney McCullough of Post 6089 (Anderson County) for getting their story told in the November/December VFW Magazine There are currently 36 Posts under suspension nationwide. Two primary reasons why are: Improper use/accounting of Post funds, or failure to conduct meetings, even though VFW national now allows 100% electronic meetings (face-time/Zoom, etc.)

WASHINGTON — Due to supply chain and staffing shortages, the vendor contracted by the Government Publishing Office to provide printing services for the Department of Veterans Affairs is experiencing delays in printing and mailing notification letters to Veterans and claimants. The disruption may impact the ability of some claimants to meet required deadlines via written correspondence with VA.

In response to the mailing delays and to protect the best interest of claimants, the Veterans Benefits Administration is extending their response period by 90-calendar days for claimants with letters dated between July 13, 2021 and Dec. 31, 2021.

If a claimant does not reply to a time-limited notification, such as, making an election of benefits or services, or reporting for a scheduled compensation and pension examination, VBA will not take adverse action to deny, reduce or terminate benefits and services unless: 1) the claimant is contacted and there is documentation of their right to respond; 2) the requested information has been received; or 3) the response period has lapsed.

VA and GPO are proactively working to quickly address the mailing delays.

NOTE: The VA currently has 153,000 claims that past the VA stated action response time.






Figure 3 -Post 9509

VA ELIGIBILITY GROUPS (Where do you qualify, or not?)

Priority group 1

We may assign you to priority group 1 if any of the below descriptions are true. You:

Have a service-connected disability that we've rated as 50% or more disabling, **or **Have a service-connected disability that we've concluded makes you unable to work (also called unemployable), **or** **Received the Medal of Honor (MOH)

Priority group 2

We may assign you to priority group 2 if you have a service-connected disability that we've rated as 30% or 40% disabling.

Priority group 3

We may assign you to priority group 3 if any of the below descriptions are true. You:

**Are a former prisoner of war (POW), or

**Received the Purple Heart medal, or

Were discharged for a disability that was caused by—or got worse because of—your active-duty service, **or

**Have a service-connected disability that we've rated as 10% or 20% disabling, or

**Were awarded special eligibility classification under Title 38, U.S.C § 1151, "benefits for individuals disabled by treatment or vocational rehabilitation"

Priority group 4

We may assign you to priority group 4 if either of the below descriptions is true. You:

**Are receiving VA aid and attendance or housebound benefits, or

**Have received a VA determination of being catastrophically disabled

Priority group 5

We may assign you to priority group 5 if any of the below descriptions are true. You:

Don't have a service-connected disability, or you have a non-compensable service-connected disability that we've rated as 0% disabling, **and you have an annual income level that's below our adjusted income limits (based on your resident zip code), **or**

**Are receiving VA pension benefits, or

**Are eligible for Medicaid programs

Priority group 6

We may assign you to priority group 6 if any of the below descriptions are true. You:

**Have a compensable service-connected disability that we've rated as 0% disabling, or

Were exposed to ionizing radiation during atmospheric testing or during the occupation of Hiroshima and Nagasaki, **or

**Participated in Project 112/SHAD, or

**Served in the Republic of Vietnam between January 9, 1962, and May 7, 1975, or

**Served in the Persian Gulf War between August 2, 1990, and November 11, 1998, or

******Served on active duty at Camp Lejeune for at least 30 days between August 1, 1953, and December 31, 1987

We may also assign you to priority group 6 if you meet all of the requirements listed below. You:

**Are currently or newly enrolled in VA health care, and

- **Served in a theater of combat operations after November 11, 1998, and
- **Were discharged less than 5 years ago

Note: As a returning combat Veteran, you're eligible for these enhanced benefits for 5 years after discharge. At the end of this enhanced enrollment period, we'll assign you to the highest priority group you qualify for at that time.

Priority group 7

We may assign you to priority group 7 if both of the below descriptions are true for you:

**Your gross household income is below the geographically adjusted income limits (GMT) for where you live, and
**You agree to pay copays
<u>View current copay rates</u>

Priority group 8

We may assign you to priority group 8 if both of the below descriptions are true for you:

Your gross household income is above VA income limits and geographically adjusted income limits for where you live, **and

**If you're assigned to priority group 8, your eligibility for VA health care benefits will depend on which subpriority group we place you in.

**View the criteria for the priority 8 subgroups

******You may be eligible for VA health care benefits if we place you in one of these subpriority groups: ******Subpriority group a

All of these must be true. You:

Have a non-compensable service-connected condition that we've rated as 0% disabling, **and **Enrolled in the VA health care program before January 16, 2003, **and** **Have remained enrolled since that date and/or were placed in this subpriority group because your eligibility status changed

Subpriority group b

All of these must be true. You:

**Have a non-compensable service-connected condition that we've rated as 0% disabling, and

**Enrolled in the VA health care program on or after June 15, 2009, and

**Have income that exceeds current VA or geographical limits by 10% or less

Subpriority group c

All of these must be true. You:

**Don't have a service-connected condition, and

**Enrolled in the VA health care program as of January 16, 2003, and

**Have remained enrolled since that date and/or were placed in this subpriority

Subpriority group d

All of these must be true. You:

**Don't have a service-connected condition, and

**Enrolled in the VA health care program on or after June 15, 2009, and

**Have income that exceeds current VA or geographical limits by 10% or less

You're not eligible for VA health care benefits if we place you in one of these subpriority groups:

Subpriority group e

All of these must be true. You:

**Have a non-compensable service-connected condition that we've rated as 0% disabling, and

**Don't meet the criteria for subpriority group a or b above

Note: You're eligible for care for your service-connected condition only.

Subpriority group g

All of these must be true. You:

Don't have a service-connected condition, **and **Don't meet the criteria for subpriority group c or d above

Once I'm enrolled in VA health care, will my priority group ever change?

Your priority group may change in some cases, such as if:

- Your income changes, or
- Your service-connected disability gets worse and we give you a higher disability rating

Update your income or other health benefits information File for increased disability compensation

If you're currently enrolled or newly enrolled in the VA health care program, and you served in a theater of combat operations after November 11, 1998, or were discharged from active duty on or after January 28, 2003, you're eligible for enhanced benefits for 5 years after discharge. During this time, we'll assign you to priority group 6. At the end of this enhanced enrollment period, we'll assign you to the highest priority group you qualify for at that time.
