### **Bonds**

By-Laws – Section 703

#### 1.Officer Bonds – Due September 1, 2021

At a minimum the Quartermaster and Commander should be bonded along with anyone who is on the post bank account.

2. Employee Bonds – Due October 1, 2021

All paid employees and volunteers handling any post funds should be bonded.

3. Forms are available at vfwsc.org under the resources tab.

### **Trustee Reports**

1. One July-30 September Due 31 October

2. One October-31 December Due 31 January

3. One January-31 March Due 30 April

4. One April-30 June Due 31 July

- 1) All trustee reports must be completed by trustees only. A minimum of two trustees must sign the report, plus the Commander
- 2) Report Form can be found at <u>vfwsc.org</u>, resources tab then reports and forms.

## 990 Tax Filing

- 1. 990-N Posts that gross 50K or less per year.
- 2. 990-EZ Short Form Less than \$200.000 gross receipts and \$500.000 end of year assets.
- 3. 990 Long Form Gross receipts over \$200.000 and/or total assets over \$500.000.
  - 990-EZ and 990 Long Form should be completed by a professional.
- 4. Go to <u>irs.gov</u> to file the 990-N electronic post card.
- 5. All Posts should be listed as a 501C-19 Veterans Exemption with the IRS.

## 990 Tax Filing Deadlines

**November 15th** for Posts whose fisical year ends June 30<sup>th</sup>.

May 15<sup>th</sup> for Posts whose fisical year ends December 31<sup>st</sup>.

# South Carolina Charities Raffle Request and Submission

- 1. File at sos.sc.gov or email charities@sos.sc.gov.
- 2. Each Post must file yearly as a charitable organization by November 15<sup>th</sup>. The cost is \$50.00 per year.
- 3. If the Post holds fundraising raffles they must file by November 15<sup>th</sup> at a cost of \$50.00.
- 4. Must fill out an annual financial report every year. You can submit a 990-EZ or a 990 as your financial report, the 990N is not allowed.

## Miscellaneous Dues & Requirements

- Post Election Reports should be submitted by April 30<sup>th</sup>.
- Department Delegate Dues are to be paid not later than May 30<sup>th</sup>.
- National Delegate Dues of \$25.00 should be paid by June 30<sup>th</sup>.

## **State & Federal Tax Requirements**

- Posts with Canteens. SC Liquor Tax is due every month to Department of Revenue.
- One Million Dollars minimum in Liquor Liability Insurance coverage is required.
- Federal Employee Taxes are paid to the IRS monthly.
- State Employee Taxes are paid to the Department of Employee and Workforce (DEW) quarterly.
- Unemployment fees are paid quarterly.
